Data Protection

Payment

Once EXTEDO receives your registration request, and upon availability, EXTEDO will send you an invoice with the registration fee and amounts payable. After receiving the invoice, payment is due within 14 days. The registration fee is net amount, and additional 19% USt (VAT) will apply and be payable by the attendee.

The payment is a pre-requisite for attendance at eRA.

EXTEDO reserves the right to hold or revoke participation as attendees/visitors at eRA and give the spot to another requester in case of any unpaid balance by 07 May 2025.

Cancellation

Cancellations by Attendee

For cancellations received on or before 15 February 2025, you will receive a 75% refund;

For cancellations received on or before 15 March 2025, you will receive a 50% refund;

You will not be refunded for cancellations received after 15 March 2025.

Any cancellation must be made in writing to <u>marketingteam@extedo.com</u>. EXTEDO must receive cancellations by the deadline date.



Cancellations by EXTEDO
